Opening

Secretary's Report

The discretionary funds are now \$6,381.53.

Mike Wick made a motion to accept the treasurer's report while Shelley Vanskiver moved for the second. All were in favor and the motion passed.

Principal's Report

Ms. Martin also spoke about the "Painting with the Principal" that was recently done. She had 5 or 6 children that came in December in efforts to promote Holy Angels.
